By participating in the ASCP/AHP/ANP 2021 Beauty Professional Appreciation Celebration you (“player” or “you”) agree to abide by and be bound by these Official Rules and the decisions of ASCP/AHP/ANP, which are final and binding in all respects and not subject to appeal.

1. Eligibility: The ASCP/AHP/ANP 2021 Beauty Professional Appreciation Celebration (the “BPAC”) is open only to legal residents of the 50 United States and the District of Columbia who are age 18 or older. Void elsewhere and where prohibited by law. The BPAC is subject to all applicable federal, state, and local laws and regulations.

Your

registration must include all requested information and comply with all instructions on the form, in addition to these Official Rules, to be eligible to win a prize. Entries that are not complete or do not adhere to these Official Rules may be disqualified at the sole discretion of ASCP/AHP/ANP. One registration per person. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. Winners of \$100 prizes will be notified at the end of each game. Winners of \$1000 prizes will be notified at the close of or directly following the close of the BPAC. ASCP/AHP/ANP shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise non-functioning contact information.

Prizes will be mailed to each verified winner within four to six weeks after completion of verification procedure. ASCP/AHP/ANP shall not be held responsible for any delays in awarding a prize for any reason outside of its control.

ASCP/AHP/ANP reserves the right to cancel, modify or suspend this BPAC at any time if fraud, technical failures, or any other errors or other causes corrupt the administration, security, integrity, or proper play of the BPAC.

ASCP/AHP/ANP does not warrant that access to the BPAC will be uninterrupted.

ASCP/AHP/ANP is not responsible for any problems that may arise, including but not limited to:

(i) lost, interrupted, inaccessible or unavailable networks, servers, satellites, websites, or other connection, availability or accessibility problems arising in connection with or over the course of the BPAC; or (ii) failed communications or communications that are jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions or hardware or software malfunctions, failures or difficulties; or (iii) failure of personal computers and/or software and hardware configurations, any technical malfunctions, failures, or difficulties, printing errors, clerical, typographical or other errors in connection with the administration of the BPAC, the processing of mail or entries, the offering or announcement of the prize or in any prize notification documents; or (iv) any other errors of any kind relating to or in connection with the BPAC, whether human, mechanical, clerical, electronic, or technical in nature; or (v) the incorrect or inaccurate capture of information, or the failure to capture any information in connection with the BPAC; or (vi) damage to a user's system occasioned by participation in this BPAC or downloading any information necessary to participate in this BPAC.

All players consent to the jurisdiction and venue of the appropriate state or federal court located in Colorado.
